No. 5419. PROTOCOL¹ ON ECONOMIC CO-OPERATION
BETWEEN THE GOVERNMENT OF THE FEDERAL
PEOPLE'S REPUBLIC OF YUGOSLAVIA AND THE GOV-
ERNMENT OF THE UNION OF BURMA. SIGNED AT
BRIONI, ON 14 JUNE 1955

In conformity with the Joint Declaration of the President of the Federal People's Republic of Yugoslavia and the Prime Minister of the Union of Burma of January 17th, 1955, and with the talks between them during the Prime Minister's official visit to Yugoslavia from June 6 to 16, 1955, as well as with a view to developing and extending economic cooperation between their countries so that it may reach a level commensurate with the firm friendship and cooperation which exist between their peoples and thereby mutually contribute to the economic development of their countries, the Government of the Federal People's Republic of Yugoslavia and the Government of the Union of Burma agree as follows :

Article 1

In view of the importance which the two Governments attach to the exchange of goods in their economic relations and taking into consideration the existing possibilities, it is hereby agreed that the competent agencies and organizations of the two countries shall consult each other and undertake steps towards increasing the exchange of goods.

Article 2

In order to establish a basis for a broader and more stable exchange of goods, the two Governments agree to conclude a five-year agreement for the Yugoslav purchase of 50.000 tons of rice yearly in Burma and such other commodities as may be agreed upon and for the Union of Burma to purchase consumer and capital goods and other goods and services provided for in existing trade and other agreements.

Article 3

With the aim of jointly promoting development in industry, in the utilization of the sources of power and natural resources, and in the other sectors of the

economy, the two Governments agree to conclude agreements on long-term cooperation and/or to facilitate the conclusion of such arrangements directly between the agencies or economic organizations of the two countries.

Article 4

With a view to mutually making use of experiences and achievements in the economic, technical and other fields, the two Governments agree to conclude an agreement on technical cooperation. This agreement will regulate such questions as the education and training of experts as well as their dispatch for work in each other's country, the use of patents, technical documentation, as well as technological processes, the organizational set up of scientific and technical institutions, the organization of processes of production and technical services, research work, etc.

Article 5

In order to increase contacts between the business representatives, organizations and institutions of the two countries in the field of exchange of goods and other aspects of economic cooperation, the two Governments agree in principle to set up a Yugoslav-Burmese Chamber of Commerce in Beograd and a Burmese-Yugoslav Chamber of Commerce in Rangoon.

Article 6

Delegations of the Government of the Federal People's Republic of Yugoslavia and of the Government of the Union of Burma shall meet by the end of 1955 in order to conclude agreements regulating the principles enumerated in this Protocol.
