#### MINISTER FOR EXTERNAL AFFAIRS

18th December, 1959

Sir,

I have the honour to refer to previous correspondence between representatives of our two Governments concerning Austrian property in Australia which is subject to the provisions of the Trading with the Enemy Act, 1939-1957, and the National Security (Enemy Property) Regulations, and Australian property in Austria which was subject to special measures by reason of the state of war or of the German occupation of Austria.

My Government's understanding of the agreement reached in this matter is as follows:

#### Article 1

The Australian Government agrees that the provisions of the Trading with the Enemy Act 1939-1957 and the National Security (Enemy Property) Regulations (hereinafter referred to as "the Commonwealth Statutes") will not be further applied to Austrian assets in Australia which are subject to such Statutes.

#### Article 2

Moneys at present held by the Australian Government in pursuance of the provisions of the Commonwealth Statutes on behalf of Austrian persons, as listed in Annex 1<sup>2</sup> attached, shall, subject to the provisions of this Agreement, be transferred to an account of the Austrian Federal Government or of an institution nominated by that Government,

whereupon the Austrian Federal Government will, subject to the provisions of Austrian Exchange Control legislation, pay the shilling equivalent of the moneys passing under this article to the persons entitled thereto.

#### Article 3

The Austrian Federal Government shall indemnify and keep indemnified the Australian Government, the Australian Treasurer and the Australian Controller of Enemy Property from all actions, suits, proceedings, claims and demands which may arise from the payment of moneys as aforesaid to the Austrian Federal Government or to such bank as may be nominated by the Austrian Federal Government.

#### Article 4

Subject to Articles 5 and 6 hereof the Australian Government shall forthwith release from control under the aforementioned Commonwealth Statutes all other moneys and property which are due to or held or managed for or on behalf of or owned by Austrian persons, as listed in Annex 21 attached, and which at the date of the coming into force of this Agreement were subject to such Statutes.

#### Article 5

Moneys which have been received under the Commonwealth Statutes on account of Austrian persons who have since died, as listed in Annex 32 attached, shall, after legal requirements in Australia have been fulfilled, be dealt with in the same manner as property referred to in Article 4 hereof.

#### Article 6

The Australian Government shall charge in respect of the moneys to be paid in pursuance of Article 2 hereof and the moneys and property to be released from control in pursuance of Articles 4 and 5 hereof fees equal to two percentum of the amount of the moneys or the value of the property as the case may be.

#### Article 7

Subject to the provisions of Austrian legislation, the Austrian Federal Government shall facilitate by all means in its power the restitution of all legal rights and interests in Austria of Australian persons and the return, without the imposition of any charges by the Austrian Federal Government in connection therewith, to Australian persons entitled, of all moneys and property in Austria as they now exist and which were subject to special measures by reason of the state of war or of the German occupation of Austria.

#### Article 8

The Austrian Federal Government undertakes that, subject to the provisions of Austrian legislation, any measures which have been or shall be taken by them or by Provincial Governments or by any governmental authorities in Austria to provide privi-

leges, immunities, reliefs, exemptions and similar advantages for Austrian persons who have suffered loss of or prejudice to moneys and property in Austria by reason of the state of war or of the German occupation of Austria, shall be applied to Australian persons and their moneys and property in Austria. This principle shall be applied especially in circumstances in which discretionary powers can be exercised and in any measures which the Austrian Federal Government, Provincial Governments or any governmental authorities in Austria may take to restore, whether as of right or ex gratia, any rights or obligations the contractual basis of which have been disturbed since 13th March, 1938.

#### Article 9

The expression "Australian persons" in Article 7 and 8 of this Agreement means persons (including juridical persons) whose moneys or property have been subject in Austria to special measures by reason of the state of war or of the German occupation of Austria solely because they were resident or carrying on business in the Commonwealth of Australia.

#### Article 10

The Austrian Federal Government undertakes to facilitate, as far as it lies within their power, the settlement of debts due by Austrian debtors to creditors in Australia who on or before the 3rd September, 1939, were resident in Australia, still outstanding and arising out of obligations entered into before 3rd September, 1939, and for that purpose, within the framework of this Agreement and upon application by the Austrian debtors, will make sterling currency available for the transfer to such creditors. The Australian Government likewise will grant facilities for the transfer to Austria of moneys released from control in pursuance of Articles 4 and 5 of this Agreement.

#### Article 11

This Agreement does not purport to exempt any moneys or property from taxation or monetary control legislation in force.

If the foregoing provisions are acceptable to your Government, I have the honour to propose that this Note and your confirmatory reply thereto be deemed to constitute and evidence the Agreement reached between our two Governments in this matter, such Agreement to be effective as from to-day's date.
