No. 5600. TRADE AGREEMENT<sup>1</sup> BETWEEN THE REPUBLIC OF AUSTRIA AND SPAIN. SIGNED AT MADRID, ON 17 JUNE 1960

---

The Austrian Government, of the one part, and the Spanish Government, of the other part, being desirous of developing trade between the two countries within the scope of the general measures adopted by the Organization for European Economic Co-operation and in conformity with the provisions of the European Monetary Agreement, have agreed as follows :

*Article I*

Each Contracting Party shall apply to the products originating in the territory of the other Contracting Party all measures relating to the liberalization and freedom from restrictions of trade which have been or may be adopted in conformity with the decisions of the Organization for European Economic Co-operation.

*Article II*

The competent Austrian authorities shall authorize the importation into Austria of the Spanish goods listed in Schedule "B"<sup>2</sup> annexed to this Agreement, at least up to the limit of the value or quantity provided for each quota.

*Article III*

The competent Spanish authorities shall authorize the importation into Spain of the Austrian goods listed in Schedule "A"<sup>3</sup> annexed to this Agreement, at least up to the limit of the value or quantity provided for each quota.

*Article IV*

The two Contracting Parties also undertake, as a general rule, to utilize the quotas in full *pro rata temporis*. Nevertheless the seasonal nature of certain of the goods listed in Schedules "A" and "B" shall be taken into due account.

*Article V*

For the purposes of this Agreement, Austrian products shall be deemed to be products originating in the Republic of Austria and Spanish goods shall be deemed to

be goods originating in the Spanish territory of the Iberian Peninsula, the Balearic Islands and the Canary Islands, the Spanish Provinces in Africa and the Spanish ports in North Africa.

#### *Article VI*

Settlement of payments relating to trade between the territories of the Contracting Parties shall be made in freely transferable currencies in accordance with the provisions of the European Monetary Agreement, signed in Paris on 5 August 1955.

#### *Article VII*

Each of the Contracting Parties reserves the right to require the presentation of invoices and certificates of origin as evidence of the value and origin of goods to be imported from the territory of the other Party.

#### *Article VIII*

A Joint Commission, composed of representatives of the two Governments, shall be established to supervise the execution and proper performance of this Agreement.

The Commission shall be competent, *inter alia*, to submit proposals for the settlement of any difficulties that may arise in the application of this Agreement and, in accordance with the experience gained, to amend the schedules of goods annexed hereto in order to promote trade between the two countries.

The Joint Commission shall meet within thirty days at the request of either Contracting Party.

#### *Article IX*

This Agreement shall enter into force on the date of its signature and shall remain in force for a period of one year.

It shall be extended from year to year by tacit agreement unless denounced by either Contracting Party three months before the expiry of its period of validity.

Schedules "A" and "B" shall likewise be valid for one year. They shall also be extended by tacit agreement for a further period of validity of the Agreement, unless denounced by either Contracting Party three months before the expiry of their period of validity.

#### *Article X*

This Agreement shall supersede the Trade Agreement, signed at Vienna on 21 March 1956, between the Republic of Austria and Spain.
