### No. 5536. AGREEMENT<sup>1</sup> ON SCIENTIFIC AND TECHNICAL COOPERATION BETWEEN THE GOVERNMENT OF THE CZECHOSLOVAK REPUBLIC AND THE IMPERIAL ETHIOPIAN GOVERNMENT. SIGNED AT ADDIS ABABA, ON 11 DECEMBER 1959

The Government of the Czechoslovak Republic and the Imperial Ethiopian Government being desirous to promote economic development and to extend scientific and technical cooperation between their Countries have agreed as follows:

#### Article I

Both Contracting Parties undertake to cooperate in scientific and technical matters in order to ensure effective utilisation of the latest achievements of science and technique for the economic development of their Countries.

#### Article II

The cooperation according to Article I of this Agreement shall consist in providing scientific and technical assistance particularly in the fields of:

- 1. Mining
- 2. Public Health
- 3. Communications
- 4. Scientific and Technical Education
- 5. Agriculture, and
- 6. Industry.

#### Article III

In order to realise the aims of the present Agreement the Government of the Czechoslovak Republic shall upon request of the Imperial Ethiopian Government :

1. Assist the Imperial Ethiopian Government in providing personnel, experts, and equipment in the fields mentioned in Article II of the present Agreement.

2. Provide scholarships and facilities for training students and trainees of the Empire of Ethiopia at Czechoslovak educational institutions and industrial establishments.

### Article IV

The conditions and scope of cooperation mentioned in Article I hereof shall be agreed upon in Protocols to be concluded by the two Contracting Parties for definite periods of time.

#### Article V

The present Agreement shall enter into force on the date of the exchange of notes confirming that this Agreement has been ratified in accordance with the constitutional procedures of the Contracting Parties and shall remain in force for a period of three years. Thereafter, it shall be automatically extended for additional periods of one year each, unless terminated by notice in writing by either Contracting Party three months before the expiry of the initial period of three years or any of the additional period of one year.
