No. 6072. AGREEMENT¹ BETWEEN THE GOVERNMENT OF THAILAND AND THE INTERNATIONAL LABOUR ORGANISATION CONCERNING THE OFFICE OF THE INTERNATIONAL LABOUR ORGANISATION FOR LIAISON WITH THE ECONOMIC COMMISSION FOR ASIA AND THE FAR EAST IN THAILAND. SIGNED AT GENEVA, ON 30 AUGUST 1961, AND AT BANGKOK, ON 1 NOVEMBER 1961

In view of the desire of the International Labour Organisation to establish an Office for liaison with the Economic Commission for Asia and the Far East in Bangkok, Thailand, and of the fact that the Government of Thailand has agreed to such establishment, and in order to facilitate the effective discharge of its functions, the Government of Thailand and the International Labour Organisation have agreed as follows:

Article 1

The Government of Thailand will grant to the International Labour Organisation in respect of its Office for liaison with the Economic Commission for Asia and the Far East in Bangkok, Thailand, and the staff of the said Office the privileges and immunities as provided in the Convention on the Privileges and Immunities of the Specialised Agencies,² and its Annex I.³

Article 2

The Government of Thailand and the International Labour Organisation agree to apply mutatis mutandis in relation to the said Office in Bangkok, Thai-

land, of the International Labour Organisation the provisions of Article III, Article V (Section 12), Article VII (Section 16), Article VIII (Section 17) and Article XI (Section 24 (a)) of the Agreement between the United Nations and the Government of Thailand relating to the headquarters of the Economic Commission for Asia and the Far East in Thailand of 26 May 1954.¹

Article 3

- 1. This Agreement shall enter into force upon signature by the representatives of both parties.
- 2. This Agreement and any supplementary agreement entered into pursuant thereto shall cease to be in force six months after either of the contracting parties shall have given notice in writing to the other of its decision to terminate the Agreement, except for such provisions as may apply to the orderly termination of the activities of the Organisation in Thailand and the disposal of its property there.
- 3. This Agreement may be modified by mutual consent. Each party shall give full and sympathetic consideration to any request for such modification.

In WITNESS WHEREOF the undersigned duly authorised representatives of the Government of Thailand and the International Labour Organisation respectively have signed the present Agreement in duplicate in the English language at Geneva this 30th day of August 1961 and at Bangkok this 1st day of November 1961.
