Sir.

I have the honour to refer to the question of Customs arrangements for civil aircraft making non-scheduled flights into the United Kingdom and Australia respectively. I have to inform you that the Government of the United Kingdom propose that the treatment accorded to supplies intended solely for use in aircraft of the designated airline of the Government of Australia, as set out in paragraph (1) of Article 4 of the Agreement for Air Services between our respective Governments signed at London on the 7th February, 1958, 2 should be accorded in the United Kingdom to supplies intended solely for use in civil aircraft registered in the Commonwealth of Australia making non-scheduled flights into the United Kingdom; and the treatment accorded to supplies intended solely for use in aircraft of the designated airline of the Government of the United Kingdom, as set out in paragraph (2) of that Article, should be accorded in Australia to supplies intended solely for use in civil aircraft registered in the United Kingdom making non-scheduled flights into the Commonwealth of Australia.

If the Government of the Commonwealth of Australia accept these proposals, I propose that this Note and your reply to that effect shall constitute an agreement between our two Governments in this matter which shall enter into force on this day's date.
