No. 6554. AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF ARGENTINA CONCERNING MILITARY SERVICE. SIGNED AT BUENOS AIRES, ON 28 NOVEMBER 1962

The Government of the Kingdom of Denmark and the Government of the Argentine Republic, desiring in a spirit of friendly understanding to overcome the difficulties relating to the military service of persons who are Danish nationals under Danish law and Argentine nationals under Argentine law, have agreed upon the following provisions :

*Article 1*

Persons having Danish nationality under the laws of the Kingdom of Denmark and Argentine nationality under the laws of the Argentine Republic shall be exempt in peacetime from the military service required of them under Argentine law on condition that, by furnishing a certificate issued by the Danish authorities, they can establish that they have complied with their military service obligation under Danish law or have been definitively exempted from such obligation.

*Article 2*

Persons having Danish nationality under the laws of the Kingdom of Denmark and Argentine nationality under the laws of the Argentine Republic shall be exempt in peacetime from the military service required of them under Danish law on condition that, by furnishing a certificate issued by the Argentine authorities, they can establish that they have complied with their military service obligation under Argentine law or have been definitively exempted from such obligation.

*Article 3*

The foregoing provisions shall in no way affect the legal position of the said persons in the matter of nationality.

*Article 4*

This Agreement shall enter into force on the date of signature and shall remain in force until terminated by either country with effect from the end of a calendar year, subject to three months' notice.
