No. 7031. AGREEMENT¹ CONCERNING THE EXCHANGE OF POSTAL PARCELS BETWEEN THE POSTAL ADMINISTRATIONS OF LIBERIA AND ISRAEL. SIGNED AT JERUSALEM, ON 18 SEPTEMBER 1962, AND AT MONROVIA, ON 1 OCTOBER 1962

The undersigned have agreed to the exchange of Postal Parcels between Liberia and Israel on the following provisions :

Article I

There shall be a regular exchange of Postal Parcels, both air and surface between Liberia and Israel. The exchange shall be effected either directly by means of exchange offices appointed by the contracting parties or per medium of other countries if the number of parcels in any direction will not warrant a direct despatch.

Article II

Except where they are inconsistent with the provisions of this Agreement, the provisions of the current Parcel Post Agreement of the U.P.U. and the Regulations for the execution of the Agreement² shall apply to the exchange of Postal Parcels between Liberia and Israel.

Article III

LIMITS OF WEIGHT

The weights of the parcels exchanged may not exceed 10 kgs. or 22 lbs.

For the correct computation of the weight, the opinion of the Administration of origin shall be considered as final, unless an obvious error has been made.

Article IV

CATEGORIES OF PARCELS

The Services of :

- 1) Insured parcels
- 2) Urgent parcels

- 3) Cash on delivery parcels
- 4) Fragile parcels and
- 5) Cumbersome parcels

shall not be available to the parcels exchanged between the two Administrations.

Article V

POSTAGE RATES AND PAYMENTS

Each contracting Administration shall advise each other of the postage rates in force as well as of the terminal transit shares adopted in its service and give beforehand notice of any alterations due to be introduced in respect of the above.

Article VI

NON-DELIVERY

The following instructions may be given by the senders for treatment of their parcels in case of non-delivery :

- (a) Delivery to an alternative addressee in the country of destination.
- (b) Return to the sender.
- (c) Abandonment.

Other requests are not admitted. Undelivered parcels in respect of which no instructions have been given by the sender in case of non-delivery shall be returned to origin without any notification after expiration of the usual delay as provided by the regulations of the country of destination.

Article VII

SETTLEMENT OF ACCOUNTS

Each Administration receiving direct despatches, from the contracting Administration shall prepare quarterly statements showing the total of credits due in respect of the parcels received. The debtor Administration shall pay the account as early as possible and not later than after 3 months from the date of receipt of the statement.

Article VIII

MEASURES OF DETAIL

The Administrations shall have power to decide by mutual arrangements all measures of detail concerning the carrying out of this Agreement and the exchange of parcels.

Article IX

INTRODUCTION OF NEW CATEGORIES OF PARCELS

It shall be open for the two Administrations to inaugurate any of categories of parcels mentioned in Article IV, in the form of correspondence.

Article X

This Agreement shall come into operation on the 1st November 1962 and shall remain in force until one year after the date on which one party has given notice to the other party of its intention to terminate it.
