No. 7022. EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT¹ BETWEEN ISRAEL AND THE CENTRAL AFRICAN REPUBLIC CONCERNING THE ABOLITION OF VISAS FOR HOLDERS OF DIPLOMATIC AND SERVICE PASSPORTS. BANGUI, 1 AND 14 FEBRUARY 1962

Sir,

I have the honour to refer to the conversations that took place between us on 16 January 1962 regarding entry and exit visas on diplomatic and service passports, and to propose that an agreement on the subject should be concluded in the following terms :

1. The Government of the State of Israel shall exempt holders of valid diplomatic and service passports of the Central African Republic from the obligation to obtain an entry or exit visa.
2. The Government of the Central African Republic shall exempt holders of valid Israel diplomatic and service passports from the obligation to obtain an entry or exit visa.
3. Holders of Israel diplomatic and service passports who are to exercise their functions in the Central African Republic or whose stay there exceeds a period of three months shall apply in the Central African Republic for the usual permit of residence.
4. Holders of diplomatic and service passports of the Central African Republic who are to exercise their functions in Israel or whose stay there exceeds a period of three months shall apply in Israel for the usual permit of residence.

On receipt of confirmation from you that the above proposals are acceptable to the Government of the Central African Republic, the Government of the State of Israel will regard this note and your reply as constituting an agreement on the subject between our two Governments, which shall enter into force ninety days after the date of the said confirmation and may at any time be denounced by either Party at six months' notice.

¹ Came into force on 15 May 1962, ninety days from the date of the note of the Government of the Central African Republic confirming the Agreement, in accordance with the provisions of the said notes.
