No. 7465. CONVENTION<sup>1</sup> CONCERNING TECHNICAL CO-OPERATION BETWEEN THE GOVERNMENT OF THE STATE OF ISRAEL AND THE GOVERNMENT OF THE PERUVIAN REPUBLIC. SIGNED AT LIMA, ON 2 APRIL 1963

---

The Government of the State of Israel and the Government of the Peruvian Republic,

Desiring to strengthen the traditional ties of friendship existing between the two States and to encourage economic and technical co-operation between their peoples ; and

Recognizing the contribution that can be made towards the attainment of those objectives by technical co-operation conventions designed to promote the exchange of experience and knowledge with a view to stimulating the development of economic resources, expanding productive capacity and increasing the well-being of the peoples ;

Have decided, in order to achieve those ends, to conclude a Convention concerning technical co-operation, and for that purpose have appointed as their plenipotentiaries :  
The Government of the State of Israel: Dr. Michael Simon, Ambassador Extraordinary and Plenipotentiary to Peru ; and

The Government of Peru : Vice-Admiral Luis Edgardo Llosa G.P., Minister for Foreign Affairs ;

who, having exhibited their full powers, found in good and due form, have agreed as follows :

*Article I*

The High Contracting Parties declare that they are animated by a common desire to establish, at the request of either Party, technical co-operation programmes to promote economic, technical, scientific and administrative development in their respective countries.

*Article II*

Each specific technical co-operation programme or project which the two Governments decide to carry out shall be dealt with in a special agreement, and its execution shall conform to the provisions of such special agreement.

<sup>1</sup> Came into force on 11 September 1963, the date of the exchange of the instruments of ratification at Lima, in accordance with the provisions of article III.

*Article III*

This Convention shall be ratified in accordance with the legal requirements of each High Contracting Party and shall enter into force upon the exchange of the instruments of ratification.

*Article IV*

Each of the High Contracting Parties may denounce this Convention at any time by communication in writing to the other Party, and the denunciation shall take effect one year after its receipt by such Party.

*Article V*

IN WITNESS WHEREOF the above-mentioned plenipotentiaries have signed this Convention and have thereto affixed their seals.

DONE at Lima, in four identical copies, in Hebrew and Spanish, all copies being authentic, on the eighth day of the month of Nisan of the year five thousand seven hundred and twenty-three, corresponding to 2 April 1963.
