#### EMBASSY OF ISRAEL

The Embassy of Israel presents its compliments to the Ministry for Foreign Affairs, and has the honour to refer to conversations that have taken place regarding an agreement between the State of Israel and the Republic of Cyprus for the reciprocal abolition of visa fees for nationals of Israel and Cyprus, bearers of Israel or Cyprus passports or other valid travel documents, respectively.

The Government of Israel is agreeable to waive visa fees for the nationals of Cyprus travelling to Israel if the Government of Cyprus would likewise waive visa fees for Israel citizens travelling to Cyprus.

The Embassy suggests that, if the above proposals are acceptable to the Government of Cyprus, this Note and the reply of the Ministry for Foreign Affairs concurring therein shall constitute an Agreement between Israel and Cyprus, which shall enter into force on 1 September 1961.

The Embassy of Israel avails itself of this opportunity to renew to the Ministry for Foreign Affairs the assurances of its highest consideration.
