# AUSTRALIAN HIGH COMMISSION NEW DELHI

Dear Foreign Secretary,

I have the honour to refer to the gift of military and other supplies by the Australian Government to the Government of India to assist India in her self defence against Chinese forces directed from Peking.

- 2. The Australian Government wishes to confirm that the following terms and conditions are to be applied in respect of the supplies furnished under the gift:
  - (a) The Government of India accepts the supplies on an f.o.b. basis at an Australian port determined by the Australian Government, and undertakes to meet all subsequent costs arising from the carriage of the supplies to India;
  - (b) The Government of India undertakes—
    - (i) that such weapons, ammunition and other supplies provided will be used only for the purposes of resisting Chinese aggression directed from Peking against India; and
    - (ii) not to dispose by gift or sale of any of the supplies without the prior agreement of the Australian Government.
- 3. The Australian Government would also wish the Government of India to agree to provide the Australian Government with the necessary facilities, should the need arise, for satisfying itself that the undertakings in the preceding sub-paragraphs are being observed by the Government of India.
- 4. If the foregoing terms are acceptable to the Government of India, I have the honour to suggest that this Note and your confirmatory reply should con-

stitute and evidence the agreement reached between our two Governments in the matter, such agreement being effective from 1st December, 1962.
