Your Excellency,

I have the honour to refer to Your Excellency's letter of the 22nd June, 1961, regarding visas of holders of diplomatic and service passports, and to suggest that an Agreement in the following terms be concluded.

- 1. The Government of Israel shall exempt holders of valid Liberian diplomatic and service passports from the obligation to obtain a visa for the purpose of entering or leaving Israel.
- 2. The Government of Liberia shall exempt holders of valid Israel diplomatic and service passports from the obligation to obtain a visa for the purpose of entering or leaving Liberia.
- 3. Holders of Israel diplomatic and service passports exercising official functions in Liberia or whose stay there exceeds the period of three months, shall apply in Liberia for the usual permits of residence.
- 4. Holders of Liberian diplomatic and service passports exercising official functions in Israel, or whose stay there exceeds the period of three months, shall apply in Israel for the usual permits of residence.

Should the above proposals be acceptable to your Government, I have the honour further to propose that this Note and Your Excellency's reply shall be regarded as constituting an agreement between our two Governments which will enter into force on the ninetieth day after the date of Your Excellency's reply and may at any time be terminated by either Government giving an advance notice of six months of its intention to do so to the other.

Mr. Ambassador:

I have the honour to acknowledge receipt of your letter No. 4507 of July 17, 1961 in reference to the concluding of an Agreement between the Government of the Republic of Liberia and the Government of the State of Israel to exempt holders of Diplomatic and Service passports of both countries from visa regulations, which letter reads word for word as follows:

The Liberian Government accepts the undertakings in this letter and understands that ninety (90) days after the receipt of this letter, Your Excellency's letter and this letter will constitute the Agreement between the Liberian Government and the Government of the State of Israel and that either Government may, at anytime, terminate this Agreement by giving an advance notice of six months to the other Party of its intention to do so.
