Mr. Minister,

I have the honour to inform you that the Government of the Union of South Africa are willing to enter into an agreement with the Government of Greece as follows:

- 1. Subject to contractual obligations, ships registered in the Union of South Africa and calling at Greek harbours will be accorded the same treatment as that accorded to vessels of any other flag, and if owners, masters or charterers of such ships feel that they have been inequitably treated, the Greek Government will be prepared to receive and consider representations which such owners, masters or charterers may wish to make about such alleged treatment.
- 2. Subject to contractual obligations, ships registered in Greece and calling at Union harbours will be accorded the same treatment as that accorded to vessels of any other flag, and if owners, masters or charterers of such ships feel that they have been inequitably treated, the Union Government will be prepared to receive and consider representations which such owners, masters or charterers may wish to make about such alleged treatment.

If your Government approves of the above, I wish to suggest that this note and your confirmatory reply in the same terms be regarded as constituting an agreement between the Government of the Union of South Africa and the Government of Greece.
