EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN CONCERNING PROPOSALS FOR AN INTEREST-FREE LOAN DURING THE FINANCIAL YEAR ENDING 31 MARCH 1965. Amman, August 31, 1964

Your Excellency,

I have the honour to refer to our recent discussions concerning proposals for an interest-free loan by the Government of the United Kingdom of Great Britain and Northern Ireland to the Government of the Hashemite Kingdom of Jordan during the financial year ending the 31st of March, 1965.

Upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, I now have the honour to propose to Your Excellency the following terms :

(a) The Government of the United Kingdom will advance to the Government of the Hashemite Kingdom of Jordan an interest-free loan of the amount of £700,000 sterling during the financial year ending the 31st of March, 1965.

(b) The above mentioned amount will be allocated as follows :

(i) Engineering design, supervision of construction, and construction of the Kafrein and Shueib Dams on the understanding that arrangements for construction are mutually acceptable, and on the understanding that the scheme will be operated in accordance with irrigation practices acceptable to the Governments of the United Kingdom and the Hashemite Kingdom of Jordan and agreed at the technical level . . .	263,500	
(ii) Continuation of support for the Central Water Authority on Water Development Schemes already undertaken or agreed upon . . . . .	169,406	
(iii) Construction and equipping of Veterinary Centres . . . .	35,000

(iv) Equipment for F.A.O. Dryland Farming Project . . . . .	32,000

(c) The loan will be repaid by the Government of the Hashemite Kingdom of Jordan to the Government of the United Kingdom in ten equal annual instalments of £70,000 beginning on the 1st of April, 1970.

If the foregoing proposals are acceptable to the Government of the Hashemite Kingdom of Jordan, I have the honour to suggest that the present Note and Your Excellency's reply in that sense should be regarded as constituting an agreement between the two Governments in this matter.

Please accept, Your Excellency, the assurance of my highest consideration.
