Dear Mr. Secretary,

I have the honor to state that following discussions with representatives of the United States Navy Ships Stores Office during their visit in Israel last March, and with personnel of the United States Embassy in Tel Aviv, Israel manufacturers of various textile, leather garments, jewelry and arts and crafts offered their merchandise for sale to the United States Navy Ships Stores overseas, and tentative orders amounting to about \$250,000 were placed.

It was agreed that, subject to governmental confirmation, these goods, and any other future orders to be placed in Israel by Non-Appropriated Fund Activities of the United States Department of Defense, will be handled in the following manner: the individual Non-Appropriated Fund Activity will place orders on an f.o.b. Israel basis with the manufacturer, and pay in dollars against documents. Copies of such payment documents will be sent by the Activity to the Disbursing Officer in the United States Embassy in Tel Aviv. The Disbursing Officer will present these invoices once monthly to the Israel Treasury which will make available U.S. dollars in exchange for Israeli pounds owned by the United States in an amount equivalent to 35 per cent of such f.o.b. price.

If this meets with your approval I have the honor to propose that this Note and your reply thereto will constitute an agreement between our two Governments
