The Ministry of Foreign Affairs presents its compliments to the Legation of Israel and with reference to the conclusion of negotiations held on October 16, 1964 in Ankara between the Delegation of Turkey and the Delegation of Israel has the honour to propose the following :

Article 1

TRAINING

Turkish teams from the Ministry of Rural Affairs will be sent to Israel in order to receive advanced training in the field of Rural Planning and Development.

The scope, terms and conditions of this training has been decided upon as follows :

A – The training will be carried out in teams composed of participants coming from one region.

B – Three teams coming from regions with similar conditions will be trained simultaneously and constitute one group.

C – The number of participants in each team will be between 8-12, depending on the final structure and organization of the Ministry of Rural Affairs.

D – Each team will be composed by Heads of regional services of the Ministry of Rural Affairs.

E – The duration of training for each group will be between 6-8 weeks.

F – In order to achieve maximum benefit from the training programme, the Ministry of Rural Affairs will do its utmost to send as many English speaking persons as possible. It is understood that each team will include at least one English speaking participant.

G – Prior to the beginning of each course the Israeli Authorities will send an expert to Turkey to collect the necessary data and get acquainted with the local conditions of the regions concerned and meet the future trainees. The Ministry of Rural Affairs will provide all facilities for the above-mentioned Israeli experts.

H – The first group will start its training in Israel in January 1965. The training of the second group will follow in March 1965.

Article 2

EXPERTS

(a) The competent authorities of Israel agree in principle to provide one expert to be consulted on the organizational problems of the Ministry of Rural Affairs upon the request of the Turkish Government and according to the directives of His Excellency, the Minister of Rural Affairs.

(b) When needed, the request of the Turkish Government for one or two additional experts in other fields of activities of the said Ministry will be taken into consideration by the Government of Israel from case to case.

Article 3

FINANCING

Unless otherwise agreed, each country will cover the travel expenses of its nationals to the other country as well as the expenses of the return trip. Each country will cover the expenses of the nationals of the other country during their stay within its boundaries.

Article 4

IMPLEMENTATION AND VALIDITY

This Agreement will come into force in November 15, 1964, and will be valid for the fiscal year 1964-65. If a prolongation of this agreement is desirable for both parties, representatives of the two countries will meet before the termination of the current fiscal year to discuss the matter under the light of the gained experiences.

If the Government of Israel signifies its Agreement with the above-mentioned proposals, the Ministry of Foreign Affairs has the honour to propose that this note and the corresponding note in reply shall constitute an agreement between the two Governments.

The Ministry of Foreign Affairs avails itself of this opportunity to renew to the Legation of Israel the assurances of its highest consideration.
