Sir,

I have the honour to inform you that the Government of the Republic of Zambia accepts the provisions of the Agreement between the United Kingdom and the United Nations Special Fund<sup>2</sup> which governed the latter's operations in Zambia before Independence, and that it is willing to consider itself as the successor to the United Kingdom Government with respect to Zambia under that Agreement.

Accordingly for all Plans of Operation relating to Special Fund projects currently in operation in Zambia the Government will apply the provisions of the Agreement referred to above, and it will likewise apply them to the Plans of Operation for projects which may be approved in the future.
