Modifications of the above-mentioned Agreement of 17 January 1961 and prolongations for successive one year-periods (1 November 1963-31 October 1964 and 1 November 1964-31 October 1965)

Modification of article 8 of the above-mentioned Agreement of 17 January 1961

No. 8236. TRADE AGREEMENT<sup>3</sup> BETWEEN THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE TUNISIAN REPUBLIC. SIGNED AT LONDON, ON 17 JANUARY 1961

The Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Tunisian Republic, desiring to strengthen the bonds of friendship and to consolidate the trade relations between the two countries, have agreed on the following provisions:

#### Article 1

The Government of the United Kingdom and the Government of the Tunisian Republic shall accord each other, within the framework of the regulations in force in both countries, as favourable a treatment as possible in the granting of import and export licences.

#### Article 2

The Government of the Tunisian Republic shall apply the liberalisation arrangements covered by the Tunisian Regulations governing Foreign Trade and Exchange to the import of goods originating in and consigned from the United Kingdom or the territories for whose international relations it is responsible (hereinafter referred to as "Dependent Territories").

The Government of the United Kingdom for their part shall apply the liberalisation arrangements reserved for countries in the "Relaxation Area", as defined in the Open General Licence of 25 May, 1959, and subsequent texts, but excluding the Scheduled Territories listed in the Exchange Control Act, 1947, to the import of goods originating in and imported from Tunisia.

In the Dependent Territories, Tunisian goods shall benefit from such liberalisation arrangements as are accorded in each of these territories to the countries referred to in the peceding paragraph.

#### Article 3

Non-liberalised goods originating in and consigned from the United Kingdom of Great Britain and Northern Ireland and the Dependent Territories

shown in List R annexed to this Agreement, are allowed to be imported into Tunisia in accordance with the terms and conditions set forth in that list.

Non-liberalised goods originating in and consigned from Tunisia are allowed to be imported into the United Kingdom in accordance with the terms and conditions set forth in List T, and into the Dependent Territories in accordance with the terms and conditions set forth in List T 1.

#### Article 4

The competent authorities of both countries shall furnish each other with all necessary information concerning trade between the two countries, in particular import and export statistics and statements showing the utilization of the quotas listed in this Agreement.

#### Article 5

Payments between the United Kingdom and Tunisia, including those for goods exchanged under this Agreement shall be made in accordance with the arrangements in force between the United Kingdom and the Franc area or any other arrangements which may subsequently be concluded between the Government of the United Kingdom and the Government of the Tunisian Republic.

#### Article 6

A Mixed Commission composed of representatives of both Governments shall supervise the smooth working of this Agreement. This Commission, which shall meet at the request of either Contracting Party, may modify the lists of goods annexed to this Agreement and recommend to both Governments any suitable measures for improving the trade and financial relations between the two countries. It shall furthermore examine any measures which might become necessary in the event of either of the Parties' appreciably modifying the existing arrangements for the liberalisation of imports or for gobal quotas.

#### Article 7

Lists R, T and T 1 referred to above and also the List of Dependent Territories, which are annexed to this Agreement, shall form an integral part thereof.

#### Article 8

This Agreement shall enter into force on the date of its signature and shall be valid for one year from 1 November, 1961.1

PROLONGATION UNTIL 31 OCTOBER 1963 OF THE TRADE AGREEMENT OF 17 JANUARY 1961 BETWEEN THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND TUNISIA

By agreements concluded by exchanges of notes dated at Tunis, on 1 and 14 November 1961, and on 5 December 1962 and 22 January 1963, respectively, the above-mentioned Agreement was twice extended, from 1 November 1961 to 31 October 1962, and from 1 November 1962 to 31 October 1963.

## MODIFICATIONS AND PROLONGATIONS OF THE ABOVE-MENTIONED TRADE AGREEMENT OF 17 JANUARY 1961

a) By an agreement concluded by an exchange of notes dated at Tunis, on 16 April, 21 May and 15 June 1964, the above-mentioned Agreement of 17 January 1961 was extended from 1 November 1963 to 31 October 1964, subject to the following modifications to List "R" annexed thereto (list of non-liberalized goods of British origin, the importation of which into Tunisia is authorized):

## [Translation — Traduction]

- "(a) Tractors: A quota of £300,000 shall be allocated for this item.
- "(b) Whisky: The quota provided for in the Agreement shall be increased by £5,000.
  - "(c) Passenger cars and motor vehicles for public transport:
  - "Quota increased by £10,000
  - "Old Quota: £75,000
  - "Proposed quota: £85,000
- "(d) Radio and television receiving apparatus, toys, watches, clocks and haberdashery:
  - " Maintenance of the quotas laid down."
- (b) By an agreement concluded by an exchange of letters dated at Tunis, on 26 January 1965, the above-mentioned Trade Agreement of 17 January 1961, as amended, was extended from 1 November 1964 to 31 October 1965, subject to the following further modifications to List "R" annexed thereto (lists of non-liberalized goods of British origin, the importation of which in Tunisia is authorized):

"It was agreed furthermore to renew the aforementioned Trade Agreement, taking into account the above adjustments, for a period of one year beginning on 1 November, 1964, and ending on 31 October, 1965."

These notes also record the following agreement between the parties:

## [Translation — Traduction]

"It was finally agreed that the authorities of our two countries could meet during this year on a date to be fixed by mutual agreement to discuss an increase in the amounts for the items "whisky" and "passenger cars and motor vehicles for public transport", and the addition of a separate item for men's and women's clothing, as soon as the position regarding Tunisia's balance of payments allowed."

# MODIFICATION OF ARTICLE 8 OF THE ABOVE-MENTIONED TRADE AGREEMENT OF 17 JANUARY 1961

By an agreement concluded by an exchange of letters dated at Tunis, on 26 January, and 20 May 1965, article 8 of the above-mentioned Agreement of 17 January 1961 was modified to read as follows:

## [Translation — Traduction]

#### « Article 8

- "This Agreement shall enter into force on the date of its signature and shall be valid for one year from 1 November, 1960.
- "It shall be renewed by tacit agreement from year to year unless denounced in writing by one or other of the Contracting Parties three months before the expiration of its period of validity.
- "I have the honour to request you to be good enough to submit this proposal for examination by the competent authorities of your Government."

The amending agreement came into force on 20 May 1965 by the exchange of the said letters.
