No. 8339. AGREEMENT¹ BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF ZAMBIA REGARDING TECHNICAL CO-OPERATION ON AN AGRICULTURAL PROJECT IN ZAMBIA. SIGNED AT LUSAKA, ON 12 DECEMBER 1965

Whereas the Government of Denmark and the Government of Zambia are desirous of strengthening the friendly relations between the two countries and their peoples and recognize their mutual interest in the economic and technical development of their countries ;

Now therefore it is agreed as follows :

Article 1

The Government of Denmark will cooperate with the Government of Zambia in the establishment and operation in Zambia of an agricultural project hereinafter referred to as "the project" serving the following purposes :

- (a) the establishment of settled farming communities in collaboration with the Zambia Youth Service ;
- (b) the improvement of soil fertility by means of manure, fertilizers and a rotational ley farming system ;
- (c) the study and possible propagation of a system of animal husbandry integrated with intensive diversified arable agriculture ;
- (d) the increase of domestic supplies of animal protein in Zambia ; and
- (e) the promotion of the co-operative system in agriculture.

Article 2

A training and demonstration project will be established. It will consist of

- (a) a dairy cattle centre comprising two units, and
- (b) a beef cattle centre comprising two units.

Article 3

The Government of Zambia will make available to each unit suitable, cleared areas of about 800-1,000 acres and shall finance the construction of the buildings

necessary for the individual farmers as well as the construction of milking parlours and other necessary buildings, all as specified in Clause A of the Protocol attached to this Agreement.

Article 4

The Government of Zambia will undertake the selection of farmers for the project units, make suitable counterparts available where possible for the project and pay the salaries of these counterparts.

Article 5

The Government of Zambia will furthermore make available the funds necessary for the operation of the centres, after detailed estimates have been drawn up and mutually agreed by the Governments concerned.

Article 6

The Government of Denmark will make available a manager and other experts and technicians necessary for the project and will defray all expenses incidental thereto over a period of three years. The Government of Denmark and the Government of Zambia will supply to the project such equipment as may be necessary for the operation of the four units all as is specified in Clause B of the Protocol attached to this Agreement.

Article 7

The Government of Denmark will, as a minimum, supply one female of the Black-and-White Danish Breed to each farmer of the Dairy Centre and the necessary bulls or, in the alternative, an insemination station. The total number of cattle to be supplied will be as set out in the Protocol attached to this Agreement.

Article 8

The Government of Zambia will allow importation into Zambia, free of duty and tax, of cattle, machinery, implements, tools and any other equipment and goods necessary for the project.

Article 9

The Government of Zambia undertakes to accord the following privileges to Danish experts and technicians serving in Zambia under this Agreement :

- (a) Exemption from payment of income tax in Zambia in respect of salaries received from the appropriate Danish authorities ;
- (b) importation, free of duty and tax, of such personal belongings and household effects as are set out in Clause D (1) of the Protocol attached to this Agreement.

Article 10

An advisory committee composed of representatives of the Government of Denmark and the appropriate authorities of Zambia will be set up in Zambia.

The Committee will act as an advisory agency to the Government of Denmark and the Government of Zambia on matters relating to the implementation of the project.

Article 11

At the expiration of the three-year period the share of the Government of Denmark in the project, comprising cattle, machinery, implements, and tools, will be handed over in normal serviceable condition and free of charge to the Government of Zambia. The Danish authorities shall receive no remuneration for their investments in the project or for any expenses incurred by them during the said three-year period.

Article 12

Further details relating to the contributions and tasks of the two Governments in connection with the establishment and operation of the project shall be laid down in a Protocol attached to this Agreement and forming an integral part thereof, such protocol being subject to amendment by mutual agreement between the two Governments.

Article 13

This Agreement shall come into effect on the date on which it is signed by the representatives of the two Governments and shall remain in force until 31st December 1968 unless terminated at an earlier date pursuant to the provisions of Article 14. Its period of validity may be extended or shortened by agreement between the two Governments.

Article 14

Each Contracting Party may terminate this Agreement prior to the date of expiration set out in Article 13 by giving twelve months' written notice to the other Party of its intention to terminate the Agreement.

IN WITNESS WHEREOF the undersigned, duly authorized by their respective Governments, have signed this Agreement.

PROTOCOL TO THE AGREEMENT BETWEEN THE GOVERNMENT OF DENMARK AND THE GOVERNMENT OF ZAMBIA REGARDING TECHNICAL CO-OPERATION ON AN AGRICULTURAL PROJECT IN ZAMBIA, SIGNED AT LUSAKA ON 12TH DECEMBER 1965

re Article 3

Clause A

The Government of Zambia will finance the construction of the following buildings, making the widest possible use of labour from the Zambia Youth Service :

1. For each individual farm :

- a.* housing for settlers
- b.* cow-sheds (roofed kraals)
- c.* siloes with a capacity of 30 tons.

2. For each unit :

- a.* central store and mill
- b.* central workshop and tool shed
- c.* fuel tank, diesel
- d.* spray-race.

3. In addition for both units of the dairy cattle centre :

- a.* cool-room (milk-room)
- b.* wash-room and sterilizing room
- c.* milking parlour.

re Article 6

Clause B

1. The Government of Denmark will send out and pay the salaries of the following experts :

- (*a*) 1 project manager who, to the extent desired by the authorities of Zambia, may also act as an adviser to the Government of Zambia on matters relating to the settlement programme ;
- (*b*) 1 veterinarian ;
- (*c*) 2 assistants—young agricultural officers—one for the dairy cattle centre, the other for the beef cattle centre ;
- (*d*) 2 livestock instructors, trained milk recorders, for the dairy cattle centre ;
- (*e*) 1 livestock instructor for the beef cattle centre ;

- (f) 5 machinery instructors ;
(g) 2 instructors on building operations : one mason and one carpenter.

2. (a) The Government of Denmark will supply the following equipment to the project :

1. Disc-ploughs :
4 three furrow + 1 detachable furrow
4 two furrow one-way ploughs + 1 detachable furrow.
2. Harrows :
4 disc-harrows (heavy duty)
4 disc-harrows (light-broad)
8 light (chain) harrows
2 special combi-harrows
2 rotovators.
3. Trailers :
8 mechanically unloading combitrailers
8 manure-spreading attachment
8 forage-unloaders (elevators).
4. Forage-harvesters :
4 forage-harvesters with maize equipment
4 tractor-mowers.
5. Loaders, etc. :
4 front-loaders
4 grader-blades
2 turnable earth-buckets.
6. 4 hammer mills.
7. 4 tractor sprayers.
8. Tool-bars :
three-point linkage
4 basic main-beams, steerable with supporting landwheels
4 basic main-beams, steerable with no land-wheels.
9. Attachment for tool-bars :
16 (4×4) single-seed planting units
8 (4×2) fertilizer-attachments
4 seed-boxes (grain or seed planter)
16 (4×4 or 8×2) planting machines
8 sets disc-ridgers
8 sets G/nut-lifters.
10. Hand tractors :
10 6 HP tractors with rubber wheels
rotovator attachments

- other attachments
- cart
- water pumps.
- 11. Milking-machines :
 - 8 bucket-units
 - 2 sterilizers.
- 12. Electric generators :
 - 1 large generator for 60 HP
 - 4 small generators for 6 HP.
- 13. Survey-equipment :
 - 1 theodolit
 - 2 Dumpy—or Quickset—levels.
- 14. Outfit, tools and implements for mechanics, masons and carpenters.
- 15. Hand-tools + equipment for the project.
- 16. Veterinary outfit.
- 17. Necessary seeds of tropical grasses and legumes not available in Africa.

(b) The Government of Zambia will supply the following equipment to the project :

- 8 tractors
- 2 cooling plants
- 4 spray-races, pipes and handling facilities
 - Maize-shellors, number according to capacity
 - Groundnut-decorticators, number according to capacity
 - Reticulation and supply of water ; and electrical reticulation
- 2 lorries
 - Locally available seeds
- 280 head of cattle
 - Locally available small tools.

re Article 7

Clause C

The Government of Denmark will supply up to a total of 120 females of the Black-and-White Danish Breed and will furthermore supply two bulls or an insemination station.

re Article 9

Clause D

1. Importation free of duty and tax of personal belongings and household effects shall comprise, *inter alia*, the following items :

- (a) Technical equipment and material ;
- (b) 1 motor car or 1 motor cycle ;
- (c) 1 refrigerator and 1 deep-freezer ;
- (d) 1 radio or 1 radiogram ;
- (e) minor electrical appliances ;
- (f) air conditioning apparatus ;

No expert or technician shall be allowed to sell or otherwise dispose of any of the aforementioned items except with the prior permission of the Government of Zambia ; such permission may be granted on certain conditions and subject to payment to the competent authorities of Zambia of any customs duties chargeable on the items in question.

2. In addition to the privileges referred to in the foregoing, the Government of Zambia will grant free medical assistance to the Danish experts and technicians.

3. The Government of Zambia will, free of charge, make accommodation available to all Danish experts and technicians.
