1966 and until such time as a standard agreement on the provision of technical assistance is signed between the Government of Lesotho and the United Nations Development Programme, both the Government of Lesotho and the United Nations Development Programme should consider themselves mutually bound by the provisions of the Revised Standard Agreement, signed on 8 July 1960, between the Technical Assistance Board and the Government of the United Kingdom of Great Britain and Northern Ireland, acting on behalf of the Trust, Non-Self-Governing and other Territories for whose international relations the Government of the United Kingdom is responsible.

I should appreciate it if you would kindly indicate your Government's acceptance of this proposal by quoting the full text of this letter in your reply.
