Your Excellency,

I have the honour to refer to Your Excellency's letter PO 210CYPR(2) of the 21st of February, 1966, concerning the service with the United Nations Force in Cyprus of the national contingent provided by the Government of

the United Kingdom of Great Britain and Northern Ireland. In this matter you have proposed that my Government and the United Nations should enter into an agreement in accordance with the terms provided therein.

My Government accepts this proposal and agrees that your letter and this reply shall constitute an agreement between the Government of the United Kingdom and the United Nations. My Government also gives the assurances requested in paragraphs 7 and 8 of your letter and undertakes to meet the request contained in paragraph 11 of your letter.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
