No. 8874. TREATY OF FRIENDSHIP¹ BETWEEN THE KINGDOM OF THAILAND AND THE EMPIRE OF IRAN.
SIGNED AT BANGKOK, ON 2 FEBRUARY 1967

His Majesty the King of Thailand and His Imperial Majesty the Shahanshah of Iran being desirous of consolidating and intensifying the ties of amity which happily prevails between Thailand and Iran and equally animated by their mutual need for closer cooperation between the two countries for their international relations on the basis of peace and justice and the principles of the Charter of the United Nations, have resolved to conclude a Treaty of Friendship and have appointed, for this purpose, as their Plenipotentiaries :

His Majesty the King of Thailand :

His Excellency Thanat Khoman, Minister of Foreign Affairs of the Kingdom of Thailand; and

His Imperial Majesty the Shahanshah of Iran :

His Excellency Manoutchehr Marzban, Ambassador Extraordinary and Plenipotentiary of the Empire of Iran to the Kingdom of Thailand;

Who, having communicated their full powers, found in good and due form, have agreed upon the following Articles :

Article 1

There shall be perpetual peace and everlasting amity between the two States and their peoples.

Article 2

The High Contracting Parties agree to maintain diplomatic and consular relations and agree that diplomatic and consular officers of either Party in the territory of the other shall enjoy, on a reciprocal basis, such privileges and immunities as are customarily granted by recognized principles of international law.

Article 3

The High Contracting Parties agree to consider cordially and with cooperation the further conclusion of agreements, on a reciprocal basis, relating to

commerce and navigation, consular rights and privileges, cultural relations, extradition and all other matters of common interest to both Parties.

Article 4

The High Contracting Parties agree that all disputes that may arise between them shall be settled peacefully in a spirit of friendship through normal diplomatic channels, failing to arrive to a settlement within a reasonable period, they shall resort to any practical procedure they deem more suitable in accordance with the rules and provisions of the Charter of the United Nations.

Article 5

This Treaty shall be subject to ratification by the High Contracting Parties in accordance with their respective constitutional procedures. It shall enter into force upon the exchange of the instruments of ratification, which shall take place in Teheran and shall thereafter remain in force unless and until terminated by one year's written notice.

Article 6

This Treaty is drawn up in duplicate in the Thai, Persian and English languages. In case of any divergence of interpretation the English text shall prevail.

IN WITNESS WHEREOF the Plenipotentiaries of the High Contracting Parties have signed the present Treaty and have hereunto affixed their seals.

DONE at Bangkok, this second day of February in the two thousand five hundred and tenth year of the Buddhist Era, corresponding to the thirteenth day of Bahman one thousand three hundred and forty five of Solar Hegira year, and to the year one thousand nine hundred and sixty seven of the Christian Era.
