No. 9083. CULTURAL AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF THE ARGENTINE REPUBLIC AND THE GOVERNMENT OF THE REPUBLIC OF PANAMA. SIGNED AT PANAMA CITY, ON 21 NOVEMBER 1964

---

The Government of the Republic of Panama and the Government of the Argentine Republic,

Equally desirous of promoting and developing cultural relations between the two countries,

Have decided to conclude an Agreement and for this purpose have appointed as their Plenipotentiaries :

The Government of the Republic of Panama : His Excellency Mr. Fernando Eleta A., Minister for Foreign Affairs;

The Government of the Argentine Republic : His Excellency Mr. Miguel Angel Zavala Ortíz, Minister for Foreign Affairs and Public Worship;

Who, having exchanged their full powers, found in due form, have agreed as follows :

*Article 1*

The Contracting Parties shall accord each other all possible facilities for the mutual dissemination of the culture of their respective countries, especially by means of :

- (a) Books, periodicals, maps and educational materials;
- (b) Lectures, concerts, courses and theatrical performances;
- (c) Cultural and art exhibitions in general;
- (d) Radio, television and similar media; and
- (e) Cultural, scientific, educational and documentary films.

*Article 2*

Each Contracting Party shall encourage the reproduction of the cultural, technical and scientific works of the other party.

*Article 3*

The Contracting Parties shall encourage the exchange between them of teachers, students, technicians, members of cultural, scientific and educational institutions, artists and performers.

*Article 4*

Each Contracting Party shall accord all possible facilities for the establishment and development, in its territory, of the cultural, scientific and educational institutions of the other Party.

*Article 5*

Each Contracting Party shall explore the ways and means of granting to the nationals of the other Contracting Party scholarships and other facilities to enable them to carry out studies and research or to acquire training in the scientific, technical, industrial or agricultural institutions in its own territory.

*Article 6*

The Contracting Parties shall encourage co-operation between their respective cultural, scientific and educational institutions.

*Article 7*

The Contracting Parties shall consider by what means and under what conditions equivalent degrees and diplomas acquired in their respective countries in the course of or on the conclusion of university studies or studies at other educational levels may be recognized mutually for academic purposes.

*Article 8*

The Parties agree to appoint two Commissions to act simultaneously, one in Panama and the other at Buenos Aires, in order to ensure the proper execution of this Agreement.

*Article 9*

This Agreement shall enter into force on the date of the exchange of the instruments of ratification, which shall take place at Buenos Aires, and shall continue in force until one of the Contracting Parties has given to the other written notice, at least six months in advance, of its intention to terminate the Agreement.

IN WITNESS WHEREOF the Plenipotentiaries of the High Contracting Parties have signed this Agreement and have affixed thereto their seals.
