No. 637. AGREEMENT<sup>1</sup> BETWEEN THE SWISS CONFEDE-RATION AND THE UNITED NATIONS CONCERNING A VOLUNTARY CONTRIBUTION BY SWITZERLAND TO THE UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION. SIGNED AT VIENNA, ON 13 MAY 1968

The Swiss Federal Council, desiring to assist the United Nations Industrial Development Organization (hereinafter referred to as "UNIDO") in achieving its aims, more particularly in the sphere of training, pledges a voluntary contribution to the United Nations in the amount of 1 million Swiss francs, to be payable in three equal instalments and to be used for the purposes and in accordance with the arrangements set forth below.

## Article 1

The contribution shall be used to enable nationals of developing countries to familiarize themselves with the functions of UNIDO and with its various programmes of technical assistance and to acquaint themselves with the procedures for their implementation; this programme shall be supplemented by a series of visits to selected industrialized countries.

### Article 2

The participants in the training programme shall be professional men (economists, engineers) or senior government officials who have assumed, for at least one to two years, important responsibilities in national development programmes, preferably in the industrial field. The candidates shall be nominated by their Governments, through the Resident Representative of the United Nations Development Programme. The successful candidates shall be chosen by a UNIDO Selection Committee under the chairmanship of the Executive Director; the Committee shall include a representative of UNDP.

### Article 3

Only the candidatures of officials capable of subsequently occupying in their own country responsible positions in the field of industrialization shall be considered.

### Article 4

The participants in the training programme shall be divided into small groups of persons (preferably ten to twelve) of as uniform a level as possible, belonging to the same geographical region and speaking the same language.

### Article 5

The programme shall have a duration of seven to eight weeks and shall be repeated approximately every two months for a new group.

### Article 6

The first part of the programme shall consist of an orientation course at UNIDO headquarters designed to provide participants with detailed information about the various industrial sectors. The course will enable participants to familiarize themselves with the work of each of the organization's divisions and with the procedure for the implementation of the various technical assistance programmes, including the United Nations Development Programme.

### Article 7

The preparatory course referred to in article 6 should enable the participants to benefit more fully from the second part of the training programme, consisting of study tours of industrialized countries, and to learn from practical achievements which might be relevant to the industrial promotion programme of their own country.

### Article 8

At the conclusion of the training course the participants shall prepare a report on the training they have received, to be submitted to the Executive Director.

### Article 9

UNIDO undertakes to inform the Federal Council's Delegate for Technical Co-operation, at Berne, about the programme proposed and the progress achieved.

### Article 10

The sum contributed by the Government shall be administered in accordance with the relevant provisions of the Financial Regulations and Rules of the United Nations, in particular the provisions of regulations 7.2 and 7.3 concerning voluntary contributions, gifts or donations.
