No. 9315. AGREEMENT * BETWEEN THE INTERNATIONAL ATOMIC ENERGY AGENCY AND THE GOVERNMENT OF THE SOCIALIST REPUBLIC OF ROMANIA RELATING TO THE APPLICATION OF SAFEGUARDS. SIGNED AT VIENNA, ON 27 JUNE 1968

WHEREAS the International Atomic Energy Agency (hereinafter called the "Agency") is authorized by its Statute 4 to apply safeguards at the request of a State to any of that State's activities in the field of atomic energy,

WHEREAS the Government of the Socialist Republic of Romania (hereinafter called the "Government") has requested the Agency to make some small quantities of nuclear and other material and a sub-critical assembly, all of which the Government intends to obtain from a supplier in the United Kingdom of Great Britain and Northern Ireland, subject to Agency safeguards, and

WHEREAS the Board of Governors has acceded to this request on 13 June 1968,

Now, therefore, the Agency and the Government hereby agree as follows:

- 1. The Government undertakes that it will not use in such a way as to further any military purpose the items listed in the Schedule to this Agreement.
- 2. The Agency undertakes to apply its safeguards system to these items.
- 3. The Government shall notify the Agency within three weeks after receipt of any of these items.
- 4. The Agency shall exempt the nuclear material and the nuclear-grade graphite listed in the Schedule from the application of Agency safeguards. Similarly, safeguards shall not apply in connection with the sub-critical assembly unless if contains safeguarded material.

5. No items listed in the Schedule shall be transferred out of the jurisdiction of the Government unless the Agency has agreed to such a transfer.

SCHEDULE

- 1. Nuclear material:
 - 2 metric tons of natural uranium; 450 grams of uranium enriched to 80 % in the isotope *** U.
- 2. Non-nuclear material:

70 metric tons of nuclear-grade graphite.

3. Equipment:

A "Helen" sub-critical assembly.
