Subject: Reciprocal Operating Privileges for Amateur Radio Operators

This Administration has been informed by the Israel Amateur Radio Club that recent changes have been effected by the Canadian Administration to permit visiting radio amateurs who are foreign nationals to operate their station in Canada, on a reciprocal basis.

In view of these changes, this Administration would be pleased if you would be willing to enter into a reciprocal agreement providing for:

- 1. The authorizing of Canadian licensed radio amateurs to operate their stations in Israel, providing they are current holders of licenses which require operating and technical qualifications of a standard acceptable to this Administration.
- The authorizing of Israeli licensed radio amateurs to operate their stations in Canada, providing they are current holders of licenses which require operating and technical qualifications of a standard acceptable to your Administration.
- 3. Such authorizations, when granted, would be subject to the terms and conditions prescribed by the issuing Administration.

If your Administration would be prepared to enter into an agreement in these terms, a reply from you and this letter would, if so desired, be regarded

by this Administration as constituting such an agreement to take effect from the date of your reply and to be subject to termination by either party giving the other six months' notice in writing of its intention to terminate.

This is in reply to your letter of March 22, 1967 proposing reciprocity between our two administrations to permit Israeli citizens visiting Canada and Canadian citizens visiting in Israel to operate amateur radio stations under the following conditions:

- 1. The authorizing of Israeli licensed radio amateurs to operate their stations in Canada, providing they are current holders of licenses which require operating and technical qualifications of a standard acceptable to this Administration
- 2. The authorizing of Canadian licensed radio amateurs to operate their stations in Israel, providing they are current holders of licences which require operating and tehenical qualifications of a standard acceptable to your Administration.
- 3. Such authorizations, when granted, would be subject to the terms and conditions prescribed by the issuing Administration.

We wish to confirm that we consider your letter and this reply as constituting an agreement in accordance with the terms set forth above to take effect
