No. 8969. AGREEMENT¹ FOR TECHNICAL CO-OPERATION
BETWEEN THE STATE OF ISRAEL AND THE REPUBLIC
OF CHAD. SIGNED AT JERUSALEM, ON 7 OCTOBER
1964

The Government of the State of Israel and the Government of the Republic of Chad,

Desiring to establish close relations of economic, technical and scientific co-operation between their two countries, with a view to encouraging the exchange of experience and knowledge likely to contribute to the development of the economic resources, the expansion of the productive capacity and the raising of the level of living of their peoples,

Agree as follows:

Article 1

Under this Agreement, the Government of the State of Israel and the Government of the Republic of Chad shall direct their efforts to collaborate with and assist each other more particularly to the following areas, to which they give priority:

- (a) The study of matters relating to national development and the training of manpower needed for development projects;
- (b) The teaching and education of youth with a view to preparing it for the tasks assigned to in national construction;
- (c) The study of public health problems and the training of medical staff needed to raise the level and improve the efficiency of medical services;
- (d) The development of vocational and technical training;
- (e) The development of institutions of general and scientific education;
- (f) The study of methods of improving communications, telecommunications and land, sea and air transport services, and the training of necessary staff;
- (g) Study and use of natural and industrial resources, and training of the necessary staff.

¹ Came into force on 8 February 1966 by the exchange of the instruments of ratification which took place at Fort-Lamy, in accordance with article 4.

Nevertheless, the two Governments may arrange to co-operate in any other sphere of activity upon which they mutually agree.

Article 2

The Government of the State of Israel shall, to the extent of its capacity to do so, place at the disposal of the Government of the Republic of Chad training and specialization fellowships in the fields of activity specified in article 1 above. At the request of the Government of Chad, it shall send experts, advisers and technicians to Chad.

Article 3

The Government of the State of Israel shall defray, to the extent of its capacity to do so, all the study and subsistence costs of Chad fellowship-holders in Israel, in accordance with the terms of this Agreement, the costs of travel to and from Israel of the said fellowship-holders being defrayed by the Republic of Chad.

Under this Agreement, the Government of the State of Israel shall pay the salary in Israel of Israel experts and advisers sent to Chad for periods not exceeding three months. The Government of the Republic of Chad shall place at the disposal of the experts and advisers the facilities necessary for the performance of their tasks.

The dispatch to Chad of Israel experts and advisers for periods exceeding three months shall form the subject of special agreements between the two Governments.

Article 4

This Agreement shall be ratified by the High Contracting Parties in accordance with their respective constitutional procedures. It shall enter into force upon the exchange of the instruments of ratification, which shall take place as soon as possible.

This Agreement shall be registered in accordance with Article 102 of the Charter of the United Nations.

IN WITNESS WHEREOF the undersigned have affixed their signatures to this Agreement, done at Jerusalem, on 1 Heshvan 5725, corresponding to 7 October 1964, in duplicate, in the Hebrew and French languages, both texts being equally authentic.
