No. 8970. EXCHANGE OF NOTES CONSTITUTING AN A-GREEMENT¹ BETWEEN ISRAEL AND THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND RELATING TO RECIPROCAL ARRANGEMENTS FOR LICENSING OF RADIO AMATEURS. LONDON, 3 FEBRUARY 1966, AND JERUSALEM, 24 APRIL 1966

I

3 February, 1966

Sir,

I am directed by the Postmaster General to say that he would be pleased if your Administration would be willing to enter into a reciprocal agreement with this Administration providing for:

- (i) The authorising of Israeli licensed radio amateurs to engage in amateur radio transmissions in the United Kingdom of Great Britain, Northern Ireland, the Channel Islands and the Isle of Man;
- (ii) The authorising of United Kingdom licensed radio amateurs to engage in amateur radio transmissions in Israel.

I am to suggest that the provisions of such an agreement might be as follows:

- 1. So long as the agreement was in force:
- (a) The Postmaster General would authorise to engage in amateur radio transmissions in the United Kingdom Israeli nationals who at the time when they applied to be so authorised were holders of current amateur radio transmitting licences which had been granted to them by your Administration, the operating and technical qualifications required of the licence holder by your Administration being of a standard acceptable to the Postmaster General as a basis for authorising operation in the United Kingdom.
- (b) Your Administration would authorise to engage in amateur radio transmissions in Israel United Kingdom nationals who at the time when they applied to be so authorised were holders of current amateur radio transmitting licences which had been granted to them by the Postmaster General, the operating and technical qualifications required of the licence holder by the Postmaster General

being of a standard acceptable to your Administration as a basis for authorising operation in Israel.

- 2. The authorisations referred to in 1 (a) above would be granted subject to such terms and conditions as the Postmaster General might prescribe.
- 3. The authorisations referred to in 1 (b) above would be granted subject to such terms and conditions as your Administration might prescribe.

I am to say that if your Administration would be prepared to enter into an agreement in the foregoing terms a reply from you to that effect and this letter would, if you so wished, be regarded by the Postmaster General as constituting such an agreement to take effect from the date of your reply and to be subject to termination by either party giving to the other six months notice in writing of its intention to terminate.
