AGREEMENT¹ BETWEEN THE UNITED NATIONS EDUCATIONAL, SCIENTIFIC AND CULTURAL ORGANIZATION AND THE INTERNATIONAL RELIEF UNION

In view of the Convention of 12 July 1927² instituting an International Relief Union,

In view of the Constitution creating a United Nations Educational, Scientific and Cultural Organization,³

CONSIDERING that the International Relief Union is desirous of ensuring the continuation of its work, particularly the important and original work which it has been carrying on for almost thirty years in regard to the scientific study of natural disasters and of the means of protection against them,

CONSIDERING that, during the last few years, the United Nations Educational, Scientific and Cultural Organization has been doing important work in connexion with these matters,

TAKING ACCOUNT of resolution No. 1268 (XLIII), adopted on 4 August 1967⁴ by the Economic and Social Council of the United Nations, recommending that Unesco, in conformity with its Constitution (a) take over from the International Relief Union responsibility for the scientific study of natural disasters in fields within its competence, (b) arrange for the continuation of the relevant activities of the Union, and (c) work out, in agreement with the Union, arrangements for the transfer to Unesco of the assets of the Union,

AWARE of the economic, social and human importance attached to the efforts made to mobilize the resources of science and technology with a view to securing for the peoples of the world better protection against natural disasters,

The United Nations Educational, Scientific and Cultural Organization (hereinafter referred to as Unesco), represented by its Director-General, and the International Relief Union (hereinafter referred to as the Union), represented by the President of its Executive Committee, have agreed as follows:

Article I

The Union shall, as from the date of entry into force of this Agreement, cease those of its activities in connexion with the scientific study of natural disasters and of the means of protection against them which are taken over by Unesco by virtue of the present agreement.

Article II

1. Within the framework of the functions assigned to it by its Constitution and within the limits of the available resources, Unesco shall continue the work of the Union in connexion with the scientific study of natural disasters and of the means of protection against them, in the fields within its competence.

2. Unesco reserves the right to undertake, as may be required, scientific studies of natural disasters, in collaboration with one or more of the other organizations of the United Nations system in the event of their being mutually concerned.

Article III

The Union assigns and transfers to Unesco, which accepts them, its stock of publications, the material in its documentation service and its archival documents relating to the scientific study of natural disasters, as well as the sums remaining at its disposal at the time of liquidation. An inventory of all the assets transferred shall be drawn up separately.

Article IV

The Director-General of Unesco and the President of the Executive Committee of the Union shall take all the necessary measures for the implementation of the present Agreement.

Article V

The present Agreement shall enter into force on the date of its signature, subject to the previous approval of the General Conference of Unesco and of the Executive Committee of the Union.

DONE at Paris, in two copies, in English and French, both texts being equally authentic.
