NOTE VERBALE

The Ministry of Foreign Affairs has the honour to refer to the Embassy of India's Note No. COP/202(1)/68 dated January 9th, 1969, in which is stated that the Government of India is ready to accept the offer of the Government of Denmark to make available to India in the crop year 1968/69 20,250 metric tons of Danish wheat. It is understood that the wheat will be supplied on a grant basis. The terms of delivery will be f.o.b. Danish port and the time of delivery not later than May 15th, 1969. It is further understood that the Indian authorities arrange for shipment and insurance. In doing so the Government of India will ensure observance of the principle of free circulation of ships in international trade in free and fair competition.

The rupee value of the wheat supplied shall be used for financing mutually acceptable development projects such as those in the field of irrigation.

It is suggested that this note and the acknowledgment hereof by the Embassy of India constitute an agreement between the Indian and the Danish Governments for the provision of this grant of wheat to India as part of Denmark's contribution for 1968/69 under the Food Aid Convention of the International Grains Arrangement 1967.²
