Sir,

I am writing on behalf of the United Nations Development Programme and have the honour to propose that, following the independence of Mauritius on 12 March 1968 and until such time as a standard agreement on the provision of technical assistance is signed between the Government of Mauritius and the United Nations Development Programme, both the Government of Mauritius and the United Nations Development Programme should consider themselves mutually bound by the provisions of the Revised Standard Agreement, signed on 8 July 1960 ² and amended by exchanges of letters dated 10 May 1963 ³ and 29 November 1967 ⁴ between the Organizations participating in the then Technical Assistance Board and the Government of the United Kingdom of Great Britain and Northern Ireland, acting on behalf
