Sir,

I am writing on behalf of the United Nations Development Programme and have the honour to propose that, following the independence of Mauritius on 12 March 1968 and until such time as an Agreement between the Government of Mauritius and the UNDP (Special Fund) relating to assistance from the latter is signed and comes into force, the Government of Mauritius accept the provisions of the Agreement between the United Kingdom and the United Nations Special Fund which governed Special Fund operations in Mauritius <sup>2</sup> before independence, and agree that such provisions shall be applicable both to Plans of Operation relating to UNDP projects currently in operation in Mauritius, as well as to Plans of Operation for projects which may be approved in the near future.
