The Embassy of the United States of America presents its compliments to the Department of Foreign Affairs of the Republic of the Philippines and has the honor to refer to a recent conversation between the Chief of Protocol, Ambassador Eduardo Rosal, and Minister R. M. Service, relative to extending to those dependents (of United States Government employees being newly assigned to South Vietnam) who may elect to reside in the Philippines, authorization permitting free-entry privileges into the Philippines for their unaccompanied personal effects, including motor vehicles.

The Embassy guarantees that should permission be granted for such duty-free entry, the Embassy will insure that all shipments will be consigned in the name of the dependent, c/o American Embassy, Manila and the Embassy will provide to the Department of Foreign Affairs a complete inventory of items contained in the shipment. In the same manner, the Embassy will request individual approval for personally-owned vehicles. The Embassy assures the Department that if these privileges are extended, the Embassy will insure re-exportation of the effects and vehicles.

The Embassy herewith requests that such tax-exemption privileges be accorded for the dependents of U.S. personnel being assigned to South Vietnam.
