AGREEMENT ³ BETWEEN THE GOVERNMENT OF THE
ARGENTINE REPUBLIC AND THE INTERNATIONAL
LABOUR ORGANISATION

Whereas the International Labour Organisation has decided to establish an Office in the city of Buenos Aires and the Government of the Argentine Republic has welcomed the decision of the ILO, and

Whereas the Government of the Argentine Republic is ready to grant the necessary facilities for the efficient running of the said Office,

The Government of the Argentine Republic and the International Labour Office have agreed as follows:

Article 1

1. The Convention on the privileges and immunities of the specialised agencies of the United Nations of 21 November 1947⁴ and its Annex of 10 July 1948⁵ relating to the International Labour Organisation, so far as the Argentine Republic accepted them on 10 October 1963, are applicable both to the Office of the ILO in Buenos Aires, its staff and all persons mentioned in these two instruments and to all activities carried out by the Organisation through the said Office.

2. Without prejudice to the provisions of the preceding paragraph of this article, the Government of the Argentine Republic shall grant to the ILO Office in Buenos Aires and to the persons to whom the preceding paragraph applies treatment not less favourable than that granted to any other specialised agency of the United Nations with offices in the Argentine Republic.

Article 2

The Government of the Argentine Republic shall grant to persons invited on official business to the Office of the ILO in Buenos Aires and not covered by the preceding article all the necessary facilities in respect of their entering, staying in and leaving the country.

Article 3

The Government shall afford to the International Labour Organisation every assistance within its power in securing suitable offices and the necessary telephones, electricity and water installations.

Article 4

1. This Agreement shall come into force upon signature.
2. This Agreement shall remain in force for as long as the Office of the ILO remains established in the city of Buenos Aires.

Article 5

Either of the parties may terminate the present Agreement by means of a specific communication addressed to the other. The termination shall take effect after a period of not less than one year and shall be communicated twelve months before the date on which it is to take effect.

IN WITNESS WHEREOF the undersigned, duly authorised representatives of the Government of the Argentine Republic and of the International Labour Organisation, have signed this Agreement in the city of Buenos Aires this sixth day of April 1970.
