# EMBASSY OF FRANCE TO ALGERIA THE AMBASSADOR

Algiers, 27 November 1969

Sir,

In the month of February 1969, the Minister of Agriculture and Agrarian Reform expressed the hope that the French Government would render assistance to Algeria for the training of agricultural technicians.

Technical talks were subsequently held between Algerian and French delegations. They led to the formulation of a project for an Institute of Agricultural Technology whose financing, organization and plan of operation were described in the report which was transmitted to you on 25 August 1969.

The Minister of Agriculture and Agrarian Reform has given his approval to this project. I am in a position to confirm to you that the French Government is prepared to assist you in establishing and operating this Institute for a period of at least five years.

The assistance will consist mainly in the following:

- Making available to the Institute a permanent team of technicians and teachers, and specialist consultants for short-term missions;
- Secondment to the Institute of volunteers in active national service;
- Supplying during the first year certain specific teaching materials which the Institute would not be able to acquire in time for the commencement of the training courses.

The composition of the permanent team, the conditions under which it will be made available to the Institute, the definition of consultant missions and the conditions under which they will be organized and the arrangements for supplying teaching materials shall, with a view to the implementation of the programme described in the report of 25 August 1969, be determined in conventions to be

concluded between the Caisse Centrale de Coopération Économique, acting for and on behalf of the French Government, and the Ministry of Agricultural and Agrarian Reform.

The French Government's contribution to the establishment and operation of the Institute of Agricultural Technology is part of the general programme of co-operation in agricultural training, which includes the conclusion of the Agreement concerning the National Agricultural Teaching Centre on 1 October 1968.<sup>1</sup>

I should be grateful if you would confirm your agreement to the foregoing.
