EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT ¹ BETWEEN AUSTRALIA AND BRAZIL RELATING TO THE ISSUE OF GRATIS VISAS TO VISITORS

Canberra, 16th July 1969

Excellency,

I have the honour to inform you that the Government of the Federative Republic of Brazil is desirous of entering into an agreement with the Government of the Commonwealth of Australia for the issue of gratis visas to visitors in order to encourage the exchange of tourists and other visitors between our two countries. My Government is prepared to enter into an agreement expressed in the following terms:

- 1) Brazilian nationals possessing valid Brazilian passports who desire to enter Australia temporarily and whose entry into Australia has been approved, will receive visas free of charge from the appropriate Australian visa issuing authority.
- 2) Australian citizens possessing valid Australian passports who desire to enter Brazil temporarily and whose entry into Brazil has been approved, will receive visas free of charge from the appropriate Brazilian visa issuing authority.
 - 3) Notwithstanding the foregoing, it is understood:
- (a) that the above proposals do not exempt Brazilian nationals entering Australia and Australian citizens entering Brazil from the necessity of complying with the Australian and Brazilian laws and regulations concerning the entry, residence, and gainful employment or occupation of aliens; and
- (b) that travellers who are unable to satisfy the respective immigration authorities that they comply with the laws and regulations referred to in the immediately preceding sub-paragraph are liable to be refused permission to enter or land.
- 4) The present agreement shall enter into force thirty days after the signature of the present agreement and shall remain in force until ninety days after either party notifies the other in writing of its desire to terminate the agreement.

Should the foregoing proposals prove acceptable to the Australian Government, I have the honour to suggest that the present note and your Excellency's reply thereto be regarded as constituting an Agreement on the matter between our two Governments.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
