AGREEMENT¹ BETWEEN THE GOVERNMENT OF THE
KINGDOM OF THE NETHERLANDS AND THE GOV-
ERNMENT OF INDIA CONCERNING THE DEVELOP-
MENT OF THE INSTITUTE OF CATERING TECHNOL-
OGY AND APPLIED NUTRITION AT CALCUTTA, INDIA

The Government of the Kingdom of the Netherlands and the Government of India;

Desirous of strengthening the ties of friendship existing between their nations and of promoting the good relations between their countries generally;

Recognizing the importance of providing facilities for the training of young men and women in general food management and catering technology in all its aspects;

Have agreed as follows :

Article I

1. The two Governments shall collaborate in the development of the Institute of Catering Technology and Applied Nutrition at Calcutta.

2. The Netherlands Government shall contribute towards the management and operation of the Institute by making available over a period of two years funds for fellowships, equipment and supplies up to a maximum of US \$ 56,000 (Fifty six thousand) and as specified in article II.

3. The Government of India shall, during the said period of two years and thereafter, assure the continuity of the courses and take the measures specified in articles III, IV and V, to facilitate operations under this agreement.

4. For the purpose of the execution of this project the two Governments designate competent authorities. The competent Netherlands authority is the International Technical Assistance Department of the Ministry of Foreign Affairs of the Kingdom of the Netherlands.

The competent Indian authority is the Department of Food, Government of India. The two competent authorities will enter into an agreement to be

called "Plan of Operations", specifying the contribution of either Government to this project, mentioned in articles II, III, IV and V of this Agreement.

Article II

1. The Netherlands Government shall make available funds up to a maximum of US \$ 18,000 (Eighteen thousand) for three fellowships, each of one year duration, for study abroad at an institution of advanced learning to train local staff members, who will later take over the responsibility for the training program at the Institute, or who will be responsible for similar catering technology and institutional management progress in India.

2. The Netherlands Government shall furthermore make available equipment up to a maximum of US \$38,000 (Thirty-eight thousand).

Article III

The Government of India shall take the necessary administrative and/or legislative action to secure the execution of the project and its future development. The Government will provide to cover the cost of the following items of the project :

- a.* a well-qualified national to serve as Principal of the Institute, and in addition, teaching and other administrative and clerical staff for carrying on the program of education and extension work;
- b.* appropriate buildings for the Institute with provision for lecture rooms, laboratories, kitchen and storage place as well as offices for the teaching and administrative staff;
- c.* fittings and equipment from local sources for equipping lecture rooms, laboratories, kitchens, offices etc. at the Institute;
- d.* installation and maintenance of the equipment;
- e.* cost of transportation within India for all Netherlands personnel who may be concerned with the project on behalf of the Netherlands Government.

Article IV

The Government of India will ensure that nominations of fellows for advanced studies abroad are submitted promptly and guarantee to continue to pay a salary and relative allowances to enable them to meet their commitments in their home country and to employ these persons upon their return from their studies in the Institute.

Article V

1. The Government of India will take all necessary steps for the clearance and temporary storage in the port of arrival in India and for the transportation and insurance during transportation from the port of arrival in India to the Institute, of the equipment and other goods, required in connection with the project, which are made available by the Netherlands Government.

2. The Government of India will establish procedures for exempting the Netherlands Government from duties and taxes, imposed in India, on equipment and other goods, imported into India in connection with the objectives of this Agreement, and for obtaining Customs Clearance Permits where necessary.

Article VI

The Government of India will indemnify and hold harmless the Netherlands Government and all Netherlands personnel who may be concerned with the project on behalf of the Netherlands Government against any and all liability, suits, actions, demands, damages, costs or fees on account of death, injuries to persons or property, or any other losses resulting from or connected with any bonafide act or omission performed in the course of operations covered by this Agreement.

Article VII

1. The Agreement shall come into force on the day on which the Netherlands Government and the Government of India will have informed each other in writing that the procedures constitutionally required in their respective countries have been complied with.

2. The Agreement shall remain in force for a period of two years.

3. Notwithstanding the contents of paragraph 1 of this article this Agreement shall provisionally be applied as from the date of signature.

IN WITNESS WHEREOF the undersigned, duly authorised thereto signed the present Agreement.
