The Department of Foreign Affairs of the Kingdom of Swaziland presents its compliments to the Embassy of the United States of America and has the honour to refer to the Extradition Treaty signed by the United States of America and the United Kingdom on 22 December, 1931 ² and applied to the Kingdom of Swaziland prior to the restoration of its Independence on 6 September 1968.

The Government of the Kingdom of Swaziland, after having examined and considered the said Treaty, has decided to accept the responsibilities and obligations of the Treaty, and shall regard it as binding between the United States of America and the Kingdom of Swaziland.

The Department wishes to propose that this Note and a reply indicating concurrence by the Government of the United States of America shall constitute an agreement between the two Governments in this matter.

The Department of Foreign Affairs of the Kingdom of Swaziland avails itself of this opportunity to renew to the Embassy of the United States of America the assurance of its highest consideration.
