EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT 1
BETWEEN THE GOVERNMENT OF DENMARK AND
THE GOVERNMENT OF THE UNITED ARAB REPUBLIC
CONCERNING FOOD AID TO THE UNITED ARAB
REPUBLIC

Cairo, December 7, 1970

Your Excellency,

I have been instructed by my Government to inform you as follows:

The Government of Denmark has the honour to inform Your Excellency that, under the Food Aid Convention ² the Danish Government is prepared to allocate to the Government of the U.A.R., on a grant basis, 9,678,000.00 kroner (nine million six hundred seventy eight thousand Danish kroner), on the following conditions:

- 1. The U.A.R. Government shall utilise the forementioned grant for the purchase of wheat or wheat flour from the following friendly countries: UK, USA, Canada, Australia, Argentine, Finland, Switzerland, Sweden, Norway, Japan and the E.E.C. countries.
- 2. The Danish Government shall instruct the National Bank of Denmark to transfer to the Central Bank of Egypt immediately after the exchange of these letters the sum of 2,978,000.00 (two million nine hundred seventy eight thousand Danish kroner) and the rest of it, 6,700,000.00 kroner (six million seven hundred thousand) after the first of April 1971. The Danish Government is prepared to make the transfer in any currency acceptable to the U.A.R. Government.
- 3. The U.A.R. Government shall deposit in a special account in the name of the U.A.R. Government, in the Central Bank of Egypt the equivalent of 9,678,000.00 kroner in Egyptian pounds after the completion of the purchase of the wheat or the wheat flour and notify the Danish Government of the purchases thus financed.

4. The two countries will agree together to use these local funds to assist in financing the U.A.R. Family Planning Programme. Part of the funds may also pending further consultations be used to assist in financing Egyptian-Danish cultural projects, if the U.A.R. Government should so prefer.
