Djakarta, August 18, 1970

Excellency:

I have the honor to refer to recent discussions between representatives of our two governments concerning the provision by the United States Government to the Republic of Indonesia of additional military assistance.

Subject to the availability of funds, the United States Government will furnish items of combat equipment appropriate for Indonesia's internal defense needs.

I propose that this assistance be provided on the same terms as those incorporated in the agreement entered into by our two governments on April 14, 1967,² for United States military assistance for a civic action program.

If these terms are acceptable to the Government of the Republic of Indonesia, I have the honor to propose that this note and Your Excellency's note in reply concurring therein shall constitute an agreement between our two governments, which shall enter into force on the date of Your Excellency's reply.

Accept, Excellency, the assurances of my highest consideration.
