Excellency:

I have the honor to refer to discussions between representatives of our two Governments regarding the extensions of the loans to the Government of the Republic of Korea of a number of naval vessels.

The loans of these naval vessels were made pursuant to various agreements effected by the exchange of notes signed at Seoul on January 29, 1955, the exchange of notes signed on August 29, 1955, and December 28, 1955, the exchange of notes signed on October 28 and November 4, 1960, and the exchange of notes signed on March 30, 1967.

I now have the honor to inform Your Excellency that, in response to the request of the Government of the Republic of Korea, the Government of the United States agrees to the extensions of the loans of these naval vessels for an additional period of five years commencing from their respective scheduled expiration dates under the same terms and conditions of the agreements pertaining to these vessels referred to above. These five-year

extensions of the loans of the vessels in question are in addition to the periods previously agreed as computed from the respective dates of deliveries of these vessels. Accordingly, the new expiration dates of these vessels will be as follows:
