TANZANIA ON A DANISH GRANT FOR THE MIOMBO  
RESEARCH CENTRE

Sir,

I have the honour and pleasure to inform you that the Danish Board for Technical Co-operation with Developing Countries have approved a grant of 2,042,000/- T. shs. for the Miombo Research Centre of the Selous Game Reserve Project. It is proposed that the grant should be used for the investments listed in an annex to this letter, for training of staff, and for recurrent expenses in connection with the equipment purchased with the grant.

2. The purpose of the grant is to enable the Research Centre to intensify its ecological research and in particular to enable it to collect data which can assist in the formulation of a policy on wildlife protein utilisation.

3. It is suggested that the expenses covered by this grant should be initially incurred by the Tanzanian authorities and refunded twice yearly by the Danish Government.

4. If the foregoing proposal is acceptable to the Government of the United Republic of Tanzania, I have the honour to suggest that the present Note and your reply to that effect shall be regarded as constituting an agreement between our two governments.

I avail myself of this opportunity to renew to you, Sir, the assurances of my highest consideration.
