AGREEMENT¹ BETWEEN THE KINGDOM OF GREECE
AND THE UNITED ARAB REPUBLIC ON CO-OPERATION
IN THE FIELD OF TOURISM

The Government of the Kingdom of Greece and the Government of the United Arab Republic, considering that the development of tourism between the two countries is of interest to both countries, and desiring to establish as close and effective a co-operation as possible, have agreed as follows :

Article 1

The Government of the Kingdom of Greece and the Government of the United Arab Republic shall give special attention to the development and expansion of relations between the two countries in the field of tourism.

Article 2

The two Contracting Parties undertake to investigate all possible means of simplifying travel formalities for tourists.

Article 3

The two Contracting Parties shall promote tourist publicity through the exchange of publications, brochures, films, the cinema and television, exhibitions etc., in order to increase the tourist traffic between them.

Article 4

The two Contracting Parties shall promote the exchange of experts in the field of tourism in order to keep themselves informed of the progress made by each Party with regard to tourism and to find the best means of increasing the tourist traffic between the two countries.

Article 5

The two Contracting Parties shall co-operate in order to find the most effective means of drawing up and applying tourist publicity programmes abroad which will promote the flow of tourists to both countries.

Article 6

The two Contracting Parties undertake to encourage their travel agencies to draw up joint itineraries for visits by foreign tourists to their countries.

Article 7

For the purposes of applying this Agreement, and in order to carry out consultations and submit recommendations to the competent authorities on the matters mentioned in the preceding articles, and also on any other matter with which they may decide to deal by common agreement, the Contracting Parties shall organize periodic meetings, at least once a year, of a Mixed Commission of Experts, set up for that purpose.

Article 8

Any expenses connected with tourism which result from the application of this Agreement shall be paid in accordance with the provisions of the Payments Agreement in force between the two countries.

Article 9

This Agreement shall be valid for a period of two years from the date of its entry into force. This Agreement shall be automatically extended, each time for a period of two years, unless one of the two Contracting Parties denounces it six months before the expiry of its validity.

Article 10

This Agreement shall be ratified and shall enter into force on the day of the exchange of the instruments of ratification, which shall take place at Athens.
