CONVENTION¹ CONCERNING TECHNICAL CO-OPERATION BETWEEN THE STATE OF ISRAEL AND THE REPUBLIC OF HONDURAS

The Government of the State of Israel and the Government of the Republic of Honduras,

Desiring to strengthen economic and technical co-operation between their peoples;

Recognizing the contribution that can be made towards the attainment of those objectives by technical co-operation conventions designed to promote the exchange of experience and knowledge with a view to stimulating the development of economic resources, expanding productive capacity and increasing the well-being of the peoples;

Have decided, in order to achieve those ends, to conclude a Convention concerning technical co-operation, and for that purpose have appointed as their plenipotentiaries:

The President of the State of Israel: His Excellency Mr. Shmuel R. Kapel, Ambassador Extraordinary and Plenipotentiary of Israel to Honduras; and

The President of the Republic of Honduras: His Excellency Tiburcio Carías Castillo, Minister for Foreign Affairs;

Who, having exchanged their full powers, found in good and due form, have agreed as follows:

Article I

The Contracting Parties declare that they are animated by a common desire to establish, at the request of either Party, technical co-operation programmes to promote economic and technical development in their respective countries.

Article II

Each specific technical co-operation programme and project which the two Governments decide to carry out shall be dealt with in a special agreement, and its execution shall conform to the provisions of such agreement.

Article III

This Convention shall be ratified in accordance with the legal requirements of each of the Contracting Parties and shall enter into force upon the exchange of the instruments of ratification, which shall take place at Tegucigalpa as soon as possible.

Article IV

Each of the Contracting Parties may denounce this Convention at any time by communication in writing to the other Party, and the denunciation shall take effect one year after its receipt by such Party.

IN WITNESS WHEREOF the plenipotentiaries of both Parties have signed this Convention.

DONE at Tegucigalpa, in two identical copies, in Hebrew and Spanish, both texts being equally authentic, on the twenty-second day of the month of Shevat of the year 5727, corresponding to 2 February 1967.
