The Prime Minister of the French Republic to the President of the Government of the Central African Republic

Bangui, 13 August 1960

Sir,

It is to the interest of the Central African Republic and of the French Republic that certain public establishments of the French Republic should be permitted to continue in the territory of the Central African Republic the various activities within their competence, particularly those relating to research and to aid and co-operation.

I accordingly have the honour to propose that, until such time as special agreements relating to them may be concluded, the public establishments of the French Republic listed in the annex to this letter should continue to carry on their activities in the territory of the Central African Republic in accordance with the arrangements at present in force.

I should be pleased if you would confirm your agreement with the foregoing.
