AGREEMENT¹ BETWEEN THE ORGANISATION FOR
ECONOMIC CO-OPERATION AND DEVELOPMENT
AND THE GOVERNMENT OF NEW ZEALAND CON-
CERNING THE PARTICIPATION OF NEW ZEALAND
IN THE WORK OF THE ORGANISATION IN THE FIELD
OF AGRICULTURE

The Organisation for Economic Co-operation and Development (herein-
after referred to as the " Organisation "), on the one hand, and

The Government of New Zealand, on the other hand,

With a view to ensuring the participation of New Zealand in the work of the
Organisation in the field of agriculture,

Having appointed the undersigned representatives who, being duly
authorized to that effect,

Have agreed as follows :

Article 1

The Government of New Zealand shall take part on the same basis as
Member countries of the Organisation in the activities of the Committee for
Agriculture and its Working Parties, including joint Working Parties set up
between the Committee for Agriculture and another Committee of the Or-
ganisation.

The provisions of this article shall apply to the meetings of the Committee
for Agriculture held at Ministerial level.

Article 2

The Government of New Zealand shall be entitled to send an observer to
the meetings of the Council whenever matters relating to the work of the Com-
mittee for Agriculture are considered.

The agenda and documents relating to such matters shall be communicated
to the Government of New Zealand.

Article 3

(1) The Government of New Zealand shall inform the Organisation, either
at the time of the adoption of a decision, recommendation or resolution sub-

mitted to the Council by the Committee for Agriculture, or within a period specified by the Council, whether it accepts the obligations resulting from the act concerned.

(2) As soon as practicable the Government of New Zealand shall inform the Organisation whether it accepts the obligations resulting from acts of the Organisation in the field of agriculture adopted prior to the date of signature of this Agreement.

Article 4

The Government of New Zealand shall take part in financing the activities of the Organisation in the field of agriculture on conditions which shall be fixed by common agreement between the Government of New Zealand and the Organisation.

DONE in duplicate, in Paris, this twenty-fifth day of June, nineteen hundred and seventy, in the English and French languages, each of these texts being equally authentic.
