EXCHANGE OF NOTES CONSTITUTING AN AGREEMENT'
BETWEEN THE GOVERNMENT OF DENMARK AND
THE ASIAN DEVELOPMENT BANK CONCERNING A
CONTRIBUTION FROM THE GOVERNMENT OF DENMARK TO THE TECHNICAL ASSISTANCE SPECIAL
FUND OF THE ASIAN DEVELOPMENT BANK

Copenhagen, February 28, 1972

Dear Mr. President,

I have the honour to refer to my announcement at the Fourth Annual Meeting of the Asian Development Bank held in Singapore, that the Government of Denmark intends to make a further contribution to the Technical Assistance Special Fund. I am now pleased to confirm the Government's offer of a further contribution in the following terms:

- 1. The Contribution will be in an amount of 2,800,000 Danish Kroner—Two Million Eight Hundred Thousand Danish Kroner—and will be allocated to the Technical Assistance Special Fund.
- 2. Except as otherwise provided herein, the Special Funds Rules and Regulations adopted by the Bank on 17 September 1968 (hereinafter called the Regulations) will apply to the Contribution.
- 3. The Government will, within forty-five days after the date this Agreement comes into effect, transfer the amount of the Contribution to the Bank's Special Account P with Danmarks Nationalbank, Copenhagen.
- 4. The Contribution may be used, in accordance with the standard policies and procedures of the Bank,
- (a) for financing the cost of expert services and related facilities in technical assistance operations of the Bank, whether provided on a reimbursable or a non-reimbursable basis, and in other activities of the Bank in which such services and facilities are required; and
- (b) for administrative expenses appertaining directly to the use of the Contribution under paragraph (a) above.
- 5. In the initial use of the Contribution for the purposes referred to in paragraph 4(a), at least half of the amount contributed should be used only for financing the cost of Danish experts and facilities. The Government will be happy to assist in the selection of such experts, if so requested by the Bank.

- 6. The Bank shall include appropriate information in its annual and quarterly reports with respect to the use of the Contribution.
- 7. The Government and the Bank will consult, through the representative of the Government on the Bank's Board of Directors, on any procedural details regarding implementation of this offer, and on any other matters which the parties agree to be of substantial importance.

I propose that this letter and your reply to the effect that the arrangements set forth above are acceptable to the Bank will constitute an agreement between the Government of Denmark and the Asian Development Bank, which will come into effect on April 1, 1972.
