EXCHANGE OF LETTERS CONSTITUTING AN AGREEMENT¹ BE-TWEEN THE GOVERNMENT OF DENMARK AND THE GOVERN-MENT OF THE PEOPLE'S REPUBLIC OF BANGLADESH CONCERNING A GRANT OF PESTICIDES BY THE GOVERN-MENT OF DENMARK TO THE GOVERNMENT OF BANGLADESH

ROYAL DANISH EMBASSY

Dacca, July 18, 1972

With reference to our discussions and correspondence regarding a grant of pesticides by the Government of Denmark to the Government of the People's Republic of Bangladesh, I have the honour to propose that the following provisions shall govern the transfer of the grant :

I. Subject to the following provisions and such other provisions as may be agreed upon between the Parties, the Government of Denmark shall make available to the Government of the People's Republic of Bangladesh pesticides to a value of approx. 6 million Danish kroner, and hand sprayers to a value of approx. 2.5 million Danish kroner.

II. The consignment of pesticides will include the following :

Lebaycid, or similar product of same quality and same

• •	chemical contents	approx. 65 tons
Nexion	ditto	approx. 30 tons
Kelthane	ditto	approx. 35 tons
Metasystox	ditto	approx. 30 tons
Imidan	ditto	approx. 30 tons
Sevin	ditto	approx. 30 tons
M. Parathion	ditto	approx, 105 tons

The specifications of the above mentioned pesticides will be as per specifications of the Ministry of Agriculture, Government of Bangladesh.

III. The consignment of hand sprayers will consist of sprayers standardized for use in Bangladesh or sprayers which will be acceptable to the Ministry of Agriculture, Government of Bangladesh.

IV. The Danish International Development Agency, Copenhagen, will purchase the above mentioned pesticides and sprayers and deliver the same c.i.f. at Chittagong or Chalna port. The consignment will be addressed to :

Bangladesh Agricultural Development Corporation Dacca

At least one month prior to the arrival of the goods the Danish International Development Agency will forward to the Bangladesh Agricultural Development Corporation the consignment note and the shipping bill.

V. The Bangladesh Agricultural Development Corporation acting on behalf of the Government of the People's Republic of Bangladesh will undertake all expenses involved in the clearing of the goods and their transport inside Bangladesh. It will also make arrangements for the prompt distribution and delivery of the goods.

VI. At the completion of the distribution the Ministry of Agriculture, Government of Bangladesh, will send to the Danish International Development Agency a report on the distribution of the pesticides and the sprayers.

If the foregoing provisions are acceptable to the Government of the People's Republic of Bangladesh, I have the honour to suggest that this letter and Your reply to it constitute an agreement between our two Governments on this matter.
