## AGREEMENT<sup>1</sup> BETWEEN THE GOVERNMENT OF CANADA AND THE GOVERNMENT OF BARBADOS RELATING TO THE CANADA PENSION PLAN

---

The Government of Canada and the Government of Barbados

Considering that employment in Canada by the Government of a country other than Canada is excepted employment under paragraph (j) of subsection (2) of section 6 of the Canada Pension Plan;

And that, under paragraph (f) of subsection (1) of section 7 of the Canada Pension Plan, the Governor in Council may make regulations for including in pensionable employment employment in Canada by the Government of a country other than Canada pursuant to an agreement with such employing Government;

Desiring to negotiate an agreement for including in pensionable employment employment in Canada by the Government of Barbados;

Have accordingly appointed duly authorized plenipotentiaries for this purpose, and have agreed as follows:

*Article I.* The provisions of the Canada Pension Plan and the Regulations made thereunder and in force from time to time shall form part of this Agreement.

*Article II.* The Government of Barbados agrees that employment in Canada by the said Government, other than employment stated in the schedule attached hereto, shall be included in pensionable employment under the Canada Pension Plan and the Regulations made thereunder and in force from time to time.

*Article III.* The Government of Barbados agrees, with respect to persons employed in Canada by the said Government, other than employment stated in the schedule attached hereto, and in accordance with the provisions of the Canada Pension Plan and the Regulations made thereunder and in force from time to time,

- (1) to make deductions from their contributory salary and wages,
- (2) to pay contributions as an employer of such persons,
- (3) to remit to Canada the said deductions and contributions,
- (4) to make returns in the form provided therefor, and,
- (5) without restricting the generality of the foregoing, to furnish information with respect to such persons as may be relevant for the administration and operation of the Canada Pension Plan.

*Article IV.* Canada agrees to include in pensionable employment by Regulation under the Canada Pension Plan employment in Canada by the Government of Barbados, other than employment stated in the schedule attached hereto, during the currency of this Agreement.

*Article V.* (1) This Agreement shall come into force and be effective on the first day of May, 1967, and subject to observance of the agreements and covenants herein and subject to compliance with the Canada Pension Plan and the Regulations made thereunder and in force from time to time, shall remain in force until terminated in accordance with article VI hereof.

(2) Subject to the Canada Pension Plan and the Regulations made thereunder and in force from time to time, this Agreement may be amended at any time by mutual consent.

*Article VI.* Either party may terminate this Agreement on the thirty-first (31st) day of December of any year by giving notice in writing to the other party on or before the thirtieth (30th) day of the immediately preceding June.

IN WITNESS WHEREOF the undersigned being duly authorized by their respective Governments, have signed this Agreement.

DONE in two copies at Ottawa this fourth day of July, 1968, in the English and French languages, each version being equally authentic.

#### SCHEDULE

Employment in Canada by the Government of Barbados, hereinafter listed, shall not be included in pensionable employment under this Agreement:

1. Employment in Canada by the Government of Barbados of a person who

- (a) is a citizen of Barbados and is neither a citizen of nor permanently resident in Canada; or
- (b) is, by virtue of paragraph (a) or (ab) of subsection (1) of section 62 of the Income Tax Act, exempt from Canadian income tax.

#### ANNEXE

Tout emploi au Canada pour le compte du Gouvernement de la Barbade, indiqué ci-après, ne peut entrer dans la catégorie des emplois ouvrant droit à pension aux termes du présent Accord :

1. L'emploi au Canada pour le compte du Gouvernement de la Barbade de toute personne qui est

- a) ressortissante de la Barbade et n'est ni ressortissante ni résidente à demeure du Canada ;
- b) exemptée de l'impôt canadien sur le revenu, en vertu des alinéas a ou ab du paragraphe (1) de l'article 62 de la loi de l'impôt sur le revenu.
